The sole liability of Kingspan L+A under this warranty shall be to repair or replace the defective product only and shall not exceed the purchase price from the manufacturer of the defective unit or item exclusive of shipping expense and installation charge. This warranty does not cover damage caused by misuse and is void if the purchaser makes any material alteration to the structure or finish of the product. This warranty does not cover incidental or consequential damages to person or property caused directly or indirectly by a Kingspan L+A product.

Skylight Alliance Warranty for Logistics Lighting Clients: Provide manufacturer's ten (10) year material and performance transferable warranty. Installing contractor shall apply for manufacturer's warranty, install a warrantable skylight system and complete the manufacturer's NOA (Notice of Award) and NOC (Notice of Completion) whenever applicable.

Plus five (5) warranty extension. At end of warranty period, a five (5) year extension may be obtained. The following conditions shall apply to receive a warranty extension. 1, a minimum of five (5) years of annual inspection roof reports by the consultant shall be provided for review. 2, a minimum of five (5) years of documented leak history and repairs shall be provided for review. 3, all repairs to skylights during the warranty period shall be completed by a manufacturer approved contractor and to all manufacturers' standards. 4, manufacturer reserves the right to inspect the skylights and provide recommended repairs that are to be completed prior to the issuance of the warranty extension.

This warranty specifically disclaims any Kingspan L+A liability from glass breakage, replacement cost or any other associated damages. This warranty gives you specific legal rights. There are no other warranties, expressed or implied, concerning the products except as specifically set forth above. This is a manufacturer's warranty by Kingspan L+A. To make claim, present proof of purchase to Kingspan L+A, together with picture and a written statement of the problem involved and what steps were taken to remedy the problem.
